
1. 2022 Financial Report by CTCN Service Area

The Advisory Board, at its 18th meeting, approved an Operational Budget of USD 10 M (net of Programme Support Cost (PSC)) for the year 2022. CTCN incurred a total expenditure of USD 11.9 M, including pro-bono support in the amount of USD 819 K.

CTCN has achieved an implementation rate of 119% against its 2022 Annual Operating Plan (AOP).

Figure 01 provides a comparison of approved budget vs incurred expenses, net of PSC by CTCN Service Areas.



As seen in Figure 02, 69% of the total expenditures are for Technical Assistance, 14% for CTCN Operations, 4% each for Capacity Building & Stakeholder Engagement, 3% for NDEs and Network Engagement, 2% each for Outreach and Communications and Knowledge Management Systems, and 1% each for Monitoring and Evaluation & Advisory Board and other UN Meetings.

2. Final Statement of Income and Expenditure (document # AB/2023/21/18.1)

The Final Statement of Income and Expenditure is the official statement of UNEP Accounts elaborating expenditure by accounting categories as at 31 December 2022 (Figure 03).

The Statement also includes UNIDO administered Income and Expenditure in 2022, for information only. UNIDO's expenditures have been reported against UNEP's accounting categories, and we note that there are slight variations in the descriptions of accounting categories between the two Agencies.


In the total fund balance of USD 27 million, as elaborated above,

- 44% are unearmarked funds (USD 12 million),
- 56% are earmarked with specific donor conditionalities and/or validity (USD 15 million)
- EUR 2 million from European Commission for the period 2023-2024 are not included, as the proposal is submitted to the EC and is pending approval.
