The project

- It is financed from the GEF Trust Fund (9.09 million USD) and the Special Climate Change Fund (5.25 million USD);
- It includes both mitigation and adaptation activities. Mitigation activities focus exclusively on the energy sector and are more specifically aligned with the Sustainable Energy for All (SE4ALL) initiative, whereas the adaptation activities focus exclusively on the water sector;
- The project is implemented through the use of expert consulting services and envisages mobilizing additional resources from Bank instruments, such as the Sustainable Energy Fund for Africa (SEFA) or the African Water Facility (AWF).



Components

Objective:

Support SSA Countries in scaling-up the deployment of low-carbon and climate resilient technologies.

Components:

- 1) Enhance **networking and knowledge dissemination** with respect to climate technology transfer and finance;
- 2) Enable the scaling-up of technology transfer through policy, institutional and organizational **reforms of the enabling environments** at the national and regional levels;
- 3) Integrate climate change into investment programs and projects.



1. Networking and Knowledge

1 - Knowledge Production includes:

- <u>Mapping</u> of African climate technology centers, national climate funds and potential public/private sector champions - *ongoing*
- Knowledge products on market constraints, best practices for technology transfer and mobilization of climate change finance – planning.
- Knowledge products can be produced as a response from <u>country</u> requests.

2 - Networking *includes:*

- Creation of a dedicated website > ongoing
- Network with SSA Institutions / Stakeholders / other CTCNs
- Collaboration with WIPO on adaptation technology transfer in SSA> ongoing





2. Enabling the scaling-up of technology transfer through policy, institutional and organizational reforms

Activities: enhance the enabling environment for climate change technology transfer, which is one of the main constraints in SSA countries

Mitigation includes

- Develop/update, and implement national or regional policies and strategies;
- Provide support to the establishment of appropriate institutions
- Support the design and implementation of de-risking instruments/regulations

Adaptation includes

- Support countries in conducting national climate change assessments
- Identify policy, institutional and organizational roadblocks
- Improve readiness of communities and local authorities

STATUS: framework contract with service providers enabled; ready to receive requests from Countries (up to 300'000 USD in technical assistance)



3. Mainstreaming climate change technologies into investment programs and projects

Activities: finance the advisory services required for the inclusion of climate change technologies into the preparation and implementation of investments programs and projects

MITIGATION component includes:

- Mainstreaming low carbon and clean technologies in SE4ALL Action Agendas (AA) and Investment Prospectus (IP).
- Project facilitation
- Support to access to financing,

ADAPTATION component includes:

- Support project/program preparation studies;
- Project facilitation
- Support to access to financing,

- MITIGATION: 2014: Kenya, Tanzania, Ghana and Rwanda (SE4ALL Action Agenda)
- 2015: Zimbabwe, Malawi, DRC, Angola, Zambia and Cameroon (SE4ALL Action Agendas and Investment Prospectuses)
- ADAPTATION pipeleline in development



How to apply for assistance

Eligibility: all public sector entities of SSA countries and sub-regional institutions (such as ECREEE for West Africa) or private sector entities (component 3 only).

Eligible proposals will be evaluated using the following evaluation criteria:

- (a) investment orientation of the proposal;
- (b) potential impact on climate change and technology transfer; and
- (c) country commitment demonstrated, for example, by existing national documents such as **Technology Needs Assessments** or similar approved by the Government and national institutions.
