Arrangements for Capacity-Building under the Convention

1992

- Establishment of the UNFCCC: **Article 6** focuses on education, training, public awareness, public participation, access to information and international cooperation

1997

- Adoption of the Kyoto Protocol: **Article 10(e)** contains provisions on education, training, awareness, and capacity-building

2001

- COP 7: Launch of **two frameworks guiding the implementation of capacity-building** in developing countries and in countries with economies in transition (2/CP.7; 3/CP.7)

2005

- CMP 1: Decision that the capacity-building frameworks are also **applicable to the implementation of the Kyoto Protocol** (29/CMP.1 and 30/CMP.1)

2011

- COP17: Launch of the annual **Durban Forum on capacity-building**

2012

- COP 18: Launch of the eight-year **Doha work programme & annual in-session dialogue on Article 6** of the Convention
- Establishment of the **Capacity-building Portal**

2015

- COP 21: Adoption of the Paris Agreement: **Article 11 on Capacity-building**
- Establishment of the **Paris Committee on Capacity-building**
- Request to establish the **Capacity-building Initiative for Transparency**

Aim of the Paris Committee on Capacity-building

“... to address gaps and needs, both current and emerging, in implementing capacity-building in developing country Parties and further enhance capacity-building efforts, including with regard to coherence and coordination in capacity-building activities under the Convention.” (1/CP.21, paragraph 71)

Key milestones

2015

- PCCB established by the COP
- Manages and oversees 2016-2020 capacity-building workplan

2016

- Adoption of the PCCB terms of reference
- Nomination of members

2017

- First meeting of the PCCB
- Technical exchange on 2017 focus area
- 2017 annual technical progress report
- Side event at COP 23

2018

- Second meeting of the PCCB
- 2018 annual technical progress report
- Further enhancement of the Capacity-building portal
- Two side events and one workshop at COP 24

2019

- Third meeting of the PCCB
- 2019 annual technical progress report
- COP to review the progress, need for extension, the effectiveness and enhancement of the Paris Committee on Capacity-building

Work plan

The PCCB has been tasked with overseeing and managing the **2016-2020 capacity-building workplan** launched by COP 21, which encompasses **nine areas**.

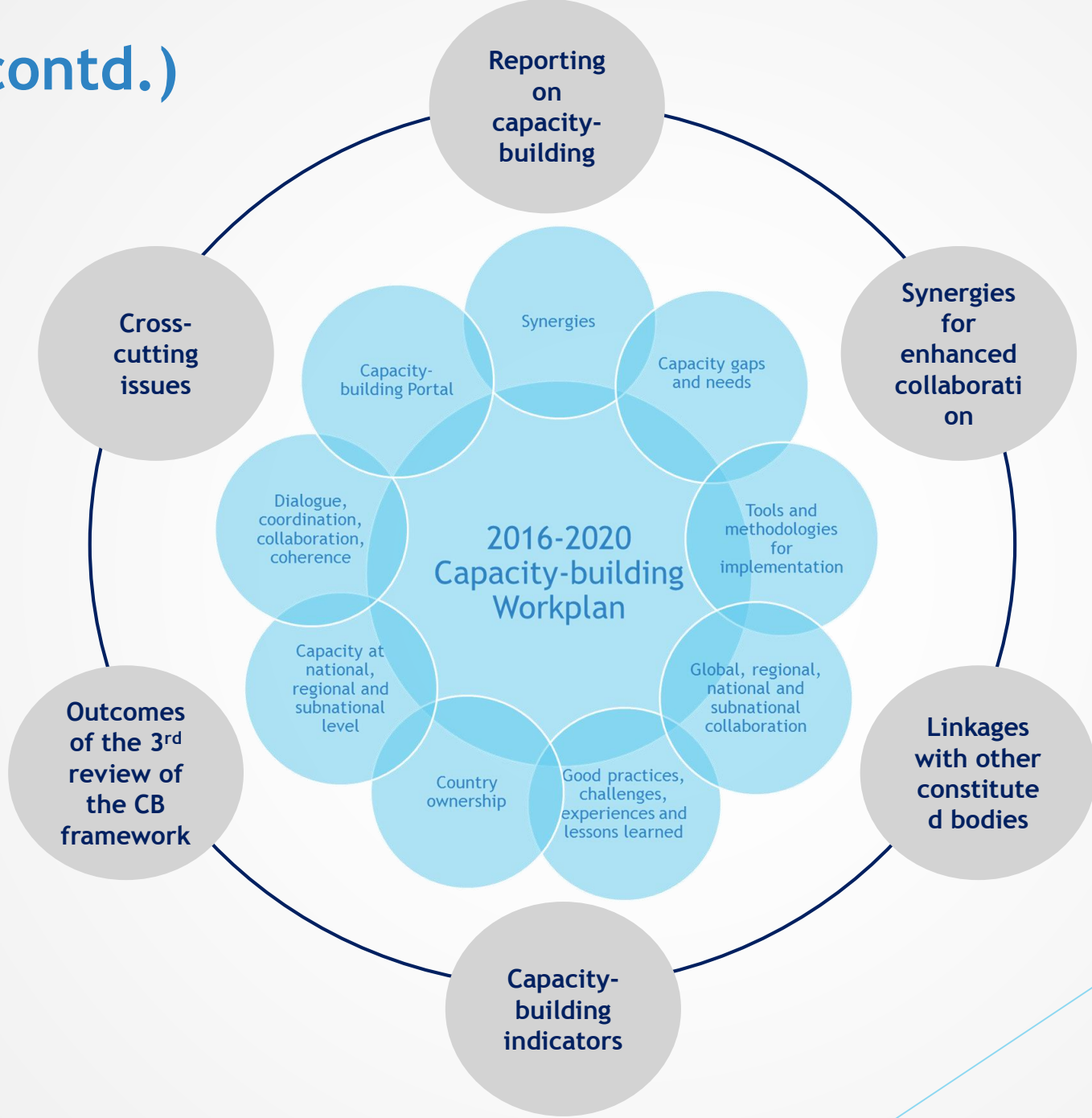

Work plan (contd.)

- ▶ Based on its aim and mandates, the PCCB adopted a **rolling work plan for the period 2017-2019**;
- ▶ Implemented through the lens of the PCCB's annual focus area or theme (2017-2019 focus area: Capacity-building activities for the implementation of NDCs);
- ▶ Supported through **four thematic PCCB working groups** focused on:

Strengthening linkages

with the constituted bodies and relevant processes and initiatives under and outside the Convention

Cross-cutting issues

such as gender responsiveness, human rights, and indigenous peoples' knowledge

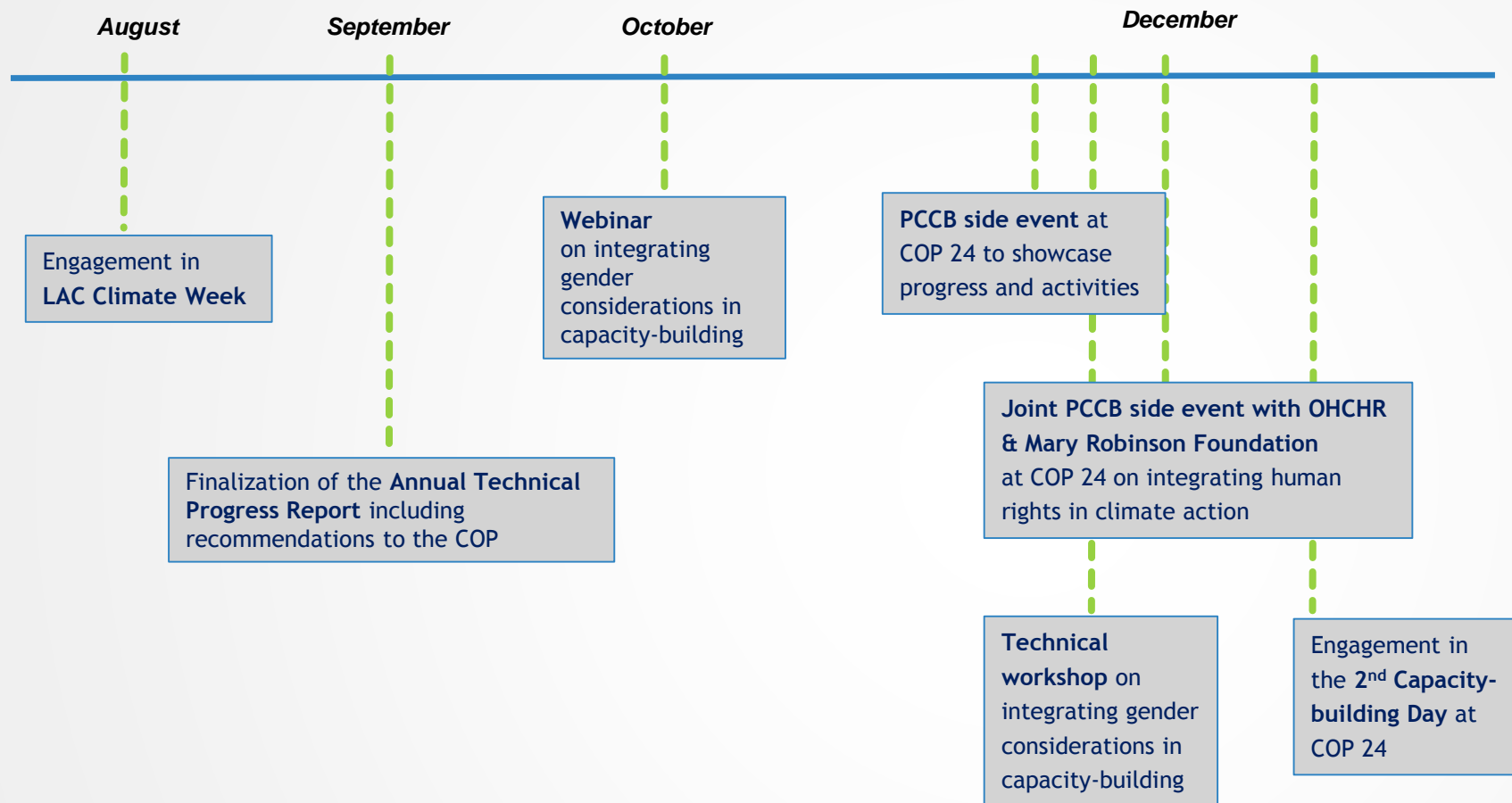

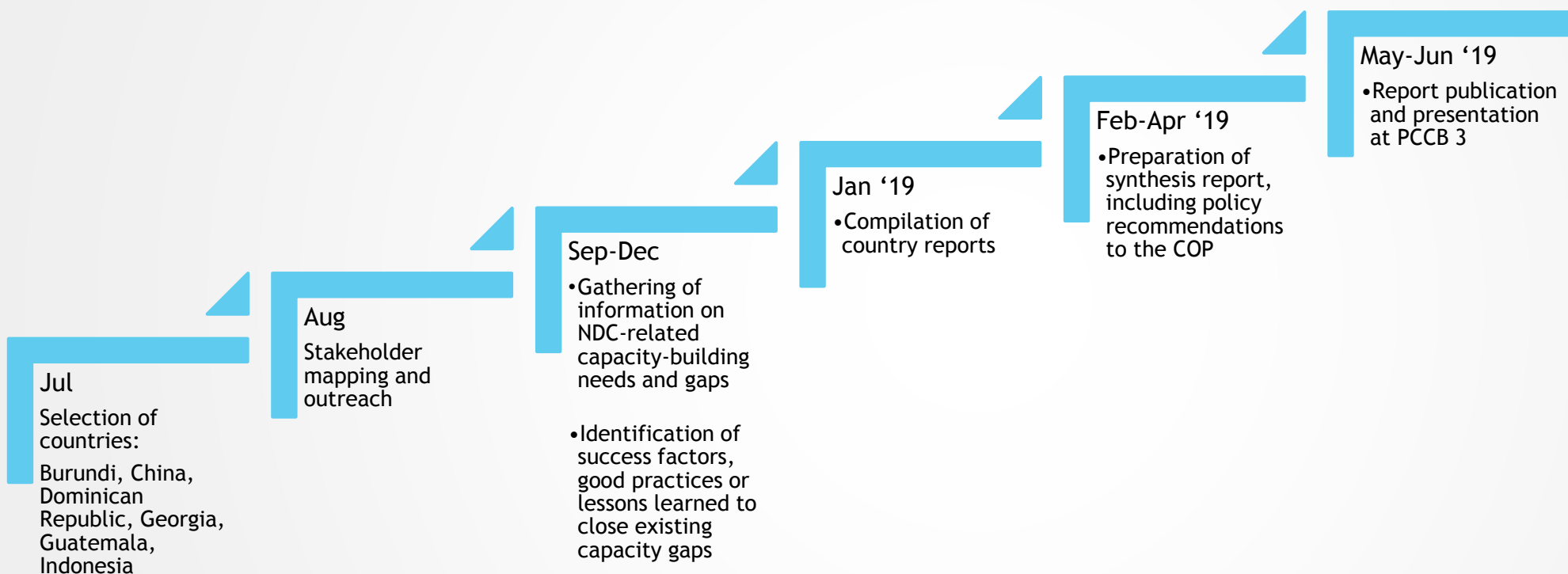


Ongoing:

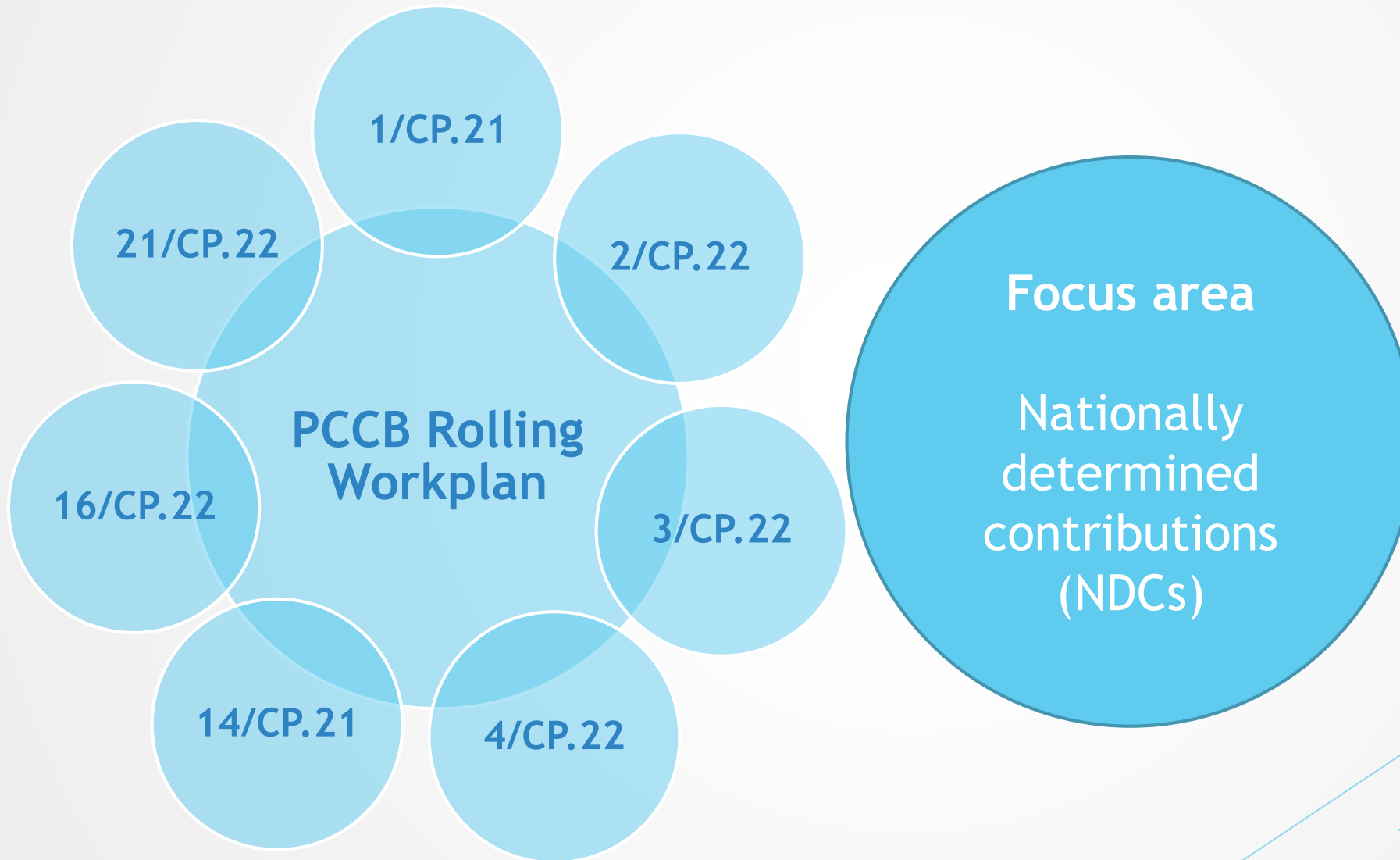

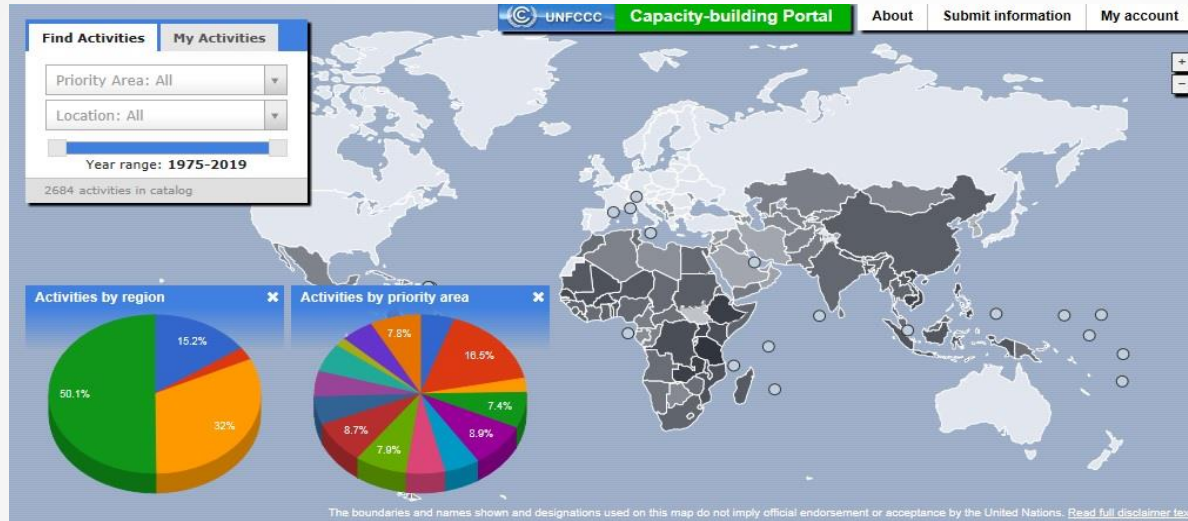
